MOTION TO RECEIVE

Mr. von Rosenvinve made a motion to receive the application for 67 Old Redding Road and Ms. Schlechter seconded. All in favor, the motion carried (5-0).

MOTION TO RECEIVE

Mr. von Rosenvinve made a motion to receive the application for 51 Old Hyde Road and Ms. Schlechter seconded. All in favor, the motion carried (5-0).

DISCUSSION/DECISION: TOWN OF WESTON (OWNER) WMC CONSULTING ENGINEERS (AGENT) CAVALRY ROAD, REPLACEMENT OF CAVALRY ROAD BRIDGE OVER SAUGATUCK RIVER

John Conte, Town Engineer came forward and stated that the project involves removing and constructing a new bridge. He noted that the bridge is shared with the Town of Westport, it is in poor condition and needs to be replaced in order to meet local, state and federal regulations. Keegan Elder, P.E. from WMC Consulting Engineers came forward and explained that they were hired by the towns to create a design for replacement of the bridge. He stated that the existing bridge is ready to fall and they qualified for a grant where the federal and state has contributed 80% of the cost. He then outlined how the work would be done and indicated the temporary waterway impacts utilizing coffer dams and controls in front of the wing walls. Discussion on the construction sequencing and de-watering plan ensued.

MOTION FOR APPROVAL

Mr. von Rosenvinge made a motion to approve the plan to replace the Cavalry Road Bridge as shown on plans prepared by WMC Consulting Engineers dated 11/13/19, as modified tonight to reflect the Town recommended double silt fence. Mr. Reiner seconded. All in favor, the motion carried (5-0).
