You are hereby ordered to appear before the Weston Conservation Commission on **September 19, 2023, at 7:30 p.m. via Zoom.**

to explain why you have delayed carrying out the plans for the stormwater retention system designed by your engineer, Mr. Wayne D'Avanzo, Fairfield County Engineering LLC, and which were approved by the Conservation Commission.

An email from you to Weston's Conservation Planner Dr. Tom Failla on August 2, 2024, further suggests that you do not intend to install the drainage improvements required by permit number. CC-23-10-COM issued to you on July 20, 2023, for "another year or two." You will recall that your application, resulting in the permit, was made only after a notice of violation had been issued.

The Land Use Office is in possession of video recordings taken July 3 and August 19, 2024, indicating that a significant volume of stormwater is running off your property, carrying silt with it. Installing the stormwater retention system as soon as possible seems to be essential.
