DISCUSSION/DECISION: APPLICATION FOR LOT DEVELOPMENT PLAN APPROVAL; 9 GREY FOX LANE, LOT 30, RESUBDIVISION OF SECTION 2 OF OLD FARM HILLS [MEDINA KOVACI / JOHN MALLOZZI] [19-05]

John Mallozzi, professional engineer representing the property owner, came forward to present the application. The applicant proposes to construct a new single family home and related site work. The applicant received approval from the Health Department and the Conservation Commission approved the application on April 25, 2019. The Commission reviewed the site plan, including the driveway, septic system, retaining walls and storm water management. Discussion ensued. A draft approval was reviewed and amended by the members.

Vice Chairman Saltzman made a motion that the Commission approve, with conditions, the Lot Development Plan for Lot 30, Section 2 of Old Farm Hills Resubdivision, 9 Grey Fox Lane, for the construction of a new single-family home, driveway, septic system, retaining walls, storm water management facilities, and related site work, as shown on the site plan and survey, as presented to and amended by the Commission. Seconded by Sally Korsh. All in favor, the motion carried (5-0). Britta Lerner and Richard Wolf absent.
