Pursuant to the Charter of the Town of Weston Article 3, Section 3.2(a), the Board of Selectmen of the Town of Weston amends sections of certain Town of Weston Ordinances, listed below, as follows:

## Town of Weston Ordinance, Chapter 2, ADMINISTRATION, ARTICLE I. IN GENERAL, Sec. 2-1.

The section of the Ordinance currently reads:

Sec. 2-1. Official signposts.

The bulletin board in the office of the town clerk and the bulletin board at the Weston Shopping Center, the signpost at Maple Street and Route 57, and the signpost at Lyons Plain Road near Emmanuel Church, are designated as the official town signposts for the posting of legal notices pertaining to town matters. All other signposts heretofore designated are discontinued for the posting of legal notices. (Res. 10-28-55) State law reference-Erection and maintenance of signposts, C.G.S. Section 7-102.

The section of the Ordinance is amended to read as follows:

Sec. 2-1. Official signposts.

## Town of Weston Ordinance, Chapter 11, SALES AND SOLICITATIONS, ARTICLE I. IN GENERAL

The section of the Ordinance currently reads:

Sec. 11-2 Same--Permit; required, fee.

Any person or organization seeking to solicit or sell shall apply to the board of selectmen or its designated agent for a permit and provide all information with respect to said solicitation, or sale, or the organization sponsoring the same, as may be reasonably required by the board of selectmen or its designated agent. A fee of five dollars (\$5.00) shall accompany each permit. The permit fee may be waived for charitable nonprofit organizations.(Ord. No. S 7-25, § 2, 5-25-77)

The section of the Ordinance is amended to read as follows:

Sec. 11-2 Same--Permit; required, fee.

Any person or organization seeking to solicit or sell shall apply to the Chief of Police for a permit and provide all information with respect to said solicitation, or sale, or the organization sponsoring the same, as may be reasonably required by the Chief of Police or its designated agent. A fee of \_\_\_\_\_ dollars (\$\_\_.00) shall accompany each permit. The permit fee may be waived for charitable nonprofit organizations.(Ord. No. S 7-25, § 2, 5-25-77; Revised \_\_-\_\_\_)

Town of Weston Ordinance, Chapter 11, SALES AND SOLICITATIONS, ARTICLE II. TAG SALES, Section 11-21 Application; conditions.

The section of the Ordinance currently reads as follows:

Sec. 11-21. Application; conditions

Any qualified person shall be permitted to conduct singularly or jointly a tag sale for a period not exceeding three (3) consecutive days once in any twelve-month period upon written application to the board of selectman setting forth the persons conducting the tag sale, the place and date, etc.; provided permission to conduct any tag sale shall be subject to the following conditions:

(1)No goods shall be brought to the premises to be used for the purpose of public sale except where several resident neighbors agree to jointly conduct such sale of personal household goods from the premises of one such neighbor or where the tag sale is conducted by a nonprofit group or organization as defined above. The office of the board of selectmen may, upon written application of two (2) or more parties, or upon application of a nonprofit group or organization, grant permission to conduct such sale.

The section of the Ordinance is amended to read as follows:

Sec. 11-21. Application; conditions

Any qualified person shall be permitted to conduct singularly or jointly a tag sale for a period not exceeding three (3) consecutive days once in any twelve-month period upon written application to the Chief of Police setting forth the persons conducting the tag sale, the place and date, etc.; provided permission to conduct any tag sale shall be subject to the following conditions:

(1)No goods shall be brought to the premises to be used for the purpose of public sale except where several resident neighbors agree to jointly conduct such sale of personal household goods from the premises of one such neighbor or where the tag sale is conducted by a nonprofit group or organization as defined above. The Chief of Police may, upon written application of two (2) or more parties, or upon application of a nonprofit group or organization, grant permission to conduct such sale.

Town of Weston Ordinance, Chapter 11, SALES AND SOLICITATIONS, ARTICLE II. TAG SALES, Section 11-22. Exceptions as to frequency.

The section of the Ordinance currently reads:

Sec. 11-22

The selectmen may upon presentation of practical difficulty or unusual hardship grant permission to conduct more than one sale in any twelve-month period. (Ord. No. S 4-10, §S 3, 5-23-73)
