

Good evening. It is 4:30 pm on Friday, December 4, 2020 and this is First Selectman Christopher Spaulding with a coronavirus update.

Keeping our schools open and operating our town safely is a priority. With that in mind, we continue to ask residents to practice social distancing when out in public, wear masks, and wash/sanitize hands frequently. This virus has shown us that it only takes one infected person to spread COVID 19 to several others in intimate settings where no masks are worn or social distance is not maintained. Asymptomatic spread of the virus can occur in gatherings of any size.
