Creating Lachat Town Farm

In 2011, a grassroots group of Westonites joined forces to save the pre-Revolutionary David Godfrey homestead from planned demolition by the Town.





Creating Lachat

The Town asked for a plan:

A master plan was created and approved by the town to create a town farm, aligned with the wishes of Leon Lachat.













Creating Lachat Town Farm






Under Leon's agreement with the Town & Nature Conservancy, the property is to be a place for non-commercial agriculture, education, and spiritual refreshment.

- "conserve its natural beauty and resources"
- "conduct research by universities or by students of plant and animal communities and of other phases of ecology and conservation"
- "for nature study by and for spiritual refreshment of responsible visitors"
- "individual, non-mechanized traversing of by such means as jogging, cross-country skiing, snowshoeing, or similar means of self-propulsion"
- "for non-commercial agricultural activities, including but not limited to a town farm or community gardens"


Creating Lachat Town Farm

When restoring the farmhouse and improving the facility, we have been very mindful of its historic character, using an architect and a contractor who specialize in historic buildings, as well as a barn restoration specialist.

Funding for the Farm

- No tax dollars are used
- How are we self-sustaining?

(on average)

Recurring costs: \$44,000

Improvements costs: \$12,000

Proposed Private Rental Event Policy

- Per year:
 - 1 large rental event (under 250 people)
 - 4 small rental events (under 100)
- Previous Fiscal Year 2019 Policy, approved by the Board of Selectmen:
 - 1 large rental event
 - 3 small rental events
 - (Covid prohibited all but 1 of these events)

The Future for Lachat Town Farm

- New building being planned, consistent with Lachat deed agreement
 - Replacement of the 3-bay garage
 - Not envisioned as a rental venue
 - The Daniel E. Offutt III Agri-Culture Center to include:
 - Art studio/Nature's Classroom
 - Teaching kitchen
 - A gathering space with a fireplace
 - Education center
 - Bathrooms



• An incredible amenity for the town and will complete foreseeable major improvements at Lachat Town Farm
































Future Plans

Estimated Operating Budget for Proposed Building

Nature Conservancy-held Maintenance Fund will help cover building upkeep in perpetuity: Average annual funds available \$25,000

- No additional staffing required.
- Designed to be a model of sustainability with state-of-the-art insulation, windows, doors & solar panels.

Operating Costs:

- Natural gas \$6,500
- Electricity \$5,500
- Maintenance & Repair \$6,000
- Cleaning Service \$8,800

Total \$29,800

Income

• Indoor enrichment programs from October & March - \$10,000



Fundraising Process

- In 2020, received a \$50,000 donation from the Offutt Trust to create plans
- Professional cost estimate on initial plans \$3.5million
- Running a successful capital campaign starts with a private period of approaching large donors
- Have received a pledge from the Offutt Trust as well as other significant pledges
- Still fundraising but have enough to confidently move through Town approval process
- Large contingency included in cost estimate.

Approval Process:

- Lachat hasn't met with Board of Selectmen yet; we wanted to present to neighbors first
- With recently finished drawings, we will next meet with the Health District, neighbors (tonight), BOS, Conservation and P&Z

Clarifications

- The new building is not conceived of as a Rental Venue; it is Non-Commercial
- The kitchen is a teaching kitchen not a Commercial Kitchen
- The "Office/Conference Room" is the size of a Ladies Room
- The 1770s farmhouse is not being replaced; rather the non-historic, dysfunctional and unattractive 3-bay garage will be replaced
- We will work with existing parking, though specified handicap parking will be required
- The funds raised for the building are going to Friends of Lachat, not the Town of Weston
- Upon completion, Friends of Lachat will give the building to the Town & Nature Conservancy
- No change in the current deed or lease is needed
- The Nature Conservancy has expressed their support
