Greetings Weston, this is First Selectwoman Sam Nestor with a Covid-19 update.

Since the beginning of the pandemic Weston has had a total of 623 cases of Covid-19. We have had an increase in Covid-19 cases of 12 individuals from August 4 to August 13, 2021.

Please note that due to the increasing spread of the Delta variant of COVID-19, new guidance on mask-wearing for both vaccinated and un-vaccinated individuals has been issued by the Centers for Disease Control (CDC) and the CT Department of Public Health (CT DPH). The Delta variant is highly contagious, and cases are growing globally as well as locally.

Weston, along with other Fairfield County Towns, is asking residents to wear a mask in indoor public spaces regardless of vaccination status. We are also encouraging mask wearing in other indoor spaces as there are increasing COVID cases in Fairfield County. The CDC has designated Fairfield County as having "substantial" community transmission. The range is as follows: low, moderate, substantial and high rates. 90% of all COVID cases in CT are of the Delta variant which is much more contagious and extra precautions are warranted.

We can slow the spread by wearing masks, which protects yourself and others. As a reminder there are residents unable to be vaccinated, including children under 12, we must be united to protect each other.

Those who are eligible and who have not done so already are encouraged to get vaccinated. Please discuss any concerns about the vaccine with your healthcare provider.
