

**WESTON PARKS & RECREATION COMMISSION MEETING
FINAL MINUTES

The Weston Parks and Recreation Commission (WPRC) held its regular monthly meeting on Monday May 13, 2019 at Weston Town Hall. Commissioners present: Eric Albert, Ed Bello, Carl Bernstein, Kirby Brendsel, Mark Crowley, Elizabeth Pocsik, and Mike Schramm. Also present was: Dave Ungar (Director Parks & Recreation). Chairman Crowley called the meeting to order at 7:49 p.m.

- 1) There was a motion to approve the minutes of the regular monthly Commission meeting on April 8, 2019 by Commissioner Brendsel that was seconded by Commissioner Pocsik. Motion was approved. For: 7 / Against: 0.

 - a) Review of action items due from April 8, 2019 monthly scheduled meeting:
 - i) Update from Director Parks & Recreation Dave Ungar on Weston Soccer Clubs request for an adjustment of the turf replacement fund fees contribution. Director Ungar has tried and is continuing to research and present other options for the use of the turf field where parties who are contributing can increase utilization. The WPRC did not have the desire to reopen and review the payment structure for the turf field at this time.

e) Parks Committee (Mr. Bernstein):

(i) Update on Bisceglie Scribner Park Fitness Trail. Currently the trail equipment is dilapidated and not getting much use. It has been recommended by residents that we have the fitness trail removed, and review is underway on following up on this recommendation. Applied for a Connecticut State Grant for updates, but it was not approved. Director Parks & Recreation Dave Ungar is checking / following up on getting the dilapidated equipment removed.

- a) Reivew and discussion on Revson Field issues by Chairman Crowley.
- b) Squash opportunity presentation and discussion by Commissioner Bernstein. Commissioner Bernstein has followed up on potentials for school support and coaching. Options could be available for both Club and youth play. Commissioner Bernstein is continuing to look into this further, including following up with Intensity toi see if there is a chance to utilize their courts.
- c) Initial discussion of 4th of July event by Director Parks & Recreation Dave Ungar. Planning is coming along, and the event is moving forward.
