DISCUSSION/DECISION: 98 GEORGETOWN ROAD, HUBLI, SITE DEVELOPMENT [22-02] Tom Quinn, PE introduced himself and property owner, Richard Hubli. Mr. Quinn showed map and architectural drawings of 98 Georgetown Road, and explained he is looking to develop the western side of the property which is approx. 1.4 acres. Mr. Quinn outlined wetlands line, sewage and drainage lines for the commission. The plan includes storm water facilities that meet the town requirement for a 50 year storm and if approved, Mr. Quinn will submit drainage report to town engineer. Ms. Schlechter questioned if any cutting and filling will be done? In response to Ms. Schlechter, Mr. Quin responded, there may be a considerable amount of earth work having to go down 8-9 feet to reach virgin soil as well as filling about four feet.

Kate Throckmorton, licensed landscape architect explains that her plan is in congestion with peak engineers and reinforces Mr. Quinn's points. Ms. Throckmorton explained her plan is to supplement the area that was disturbed with the new plants she has chosen.

Mr. Smith made a motion to approve plan with the two conditions of adding the environmental planting plan dated October 2016 with revisions March 11, 2022 be updated with any substitutions to plans are approved by landscape architect as well as Dr. Failla.
